## **NOTIFICATION**

No.F.5(58)/Policy-II/VAT/2010/ - Whereas the Ministry of External Affairs, Govt. of India have vide their letter No. D-II/451/12(5)/2007 dated 7<sup>th</sup> July, 2010, requested the Govt. of NCT of Delhi to grant facility of VAT refund in favour of the Global Development Network (GDN) in New Delhi; and whereas I am of the opinion that it is expedient in the interest of General Public so to do.

## **AMENDMENT**

In the Sixth Schedule of the Delhi Value Added Tax Act, 2004-

In the entry at Sl. No. 1, Part B relating to the list of International Organizations which can claim refund, after the sub-entry at Sl. No. (26), the following new entry shall be appended, namely:-

"(27) Global Development Network (GDN) - In respect of its official purchases in New Delhi and personal purchases of its internationally recruited officials"

This notification shall come into force with effect from 7<sup>th</sup> July, 2010.
