

NOTIFICATION NO. 7 OF 2014CORRIGENDUM

In partial modifications of earlier Notification No. 1 of 2013(F.No.A-32012/6/2012-Ad.VI) dated 1st January, 2013, it is clarified that the following Assistant Commissioners of Income Tax (Junior Time Scale) are hereby appointed to officiate as Deputy Commissioner of Income Tax (Senior Time Scale) in the Pay Scale of Rs. 15,600-39,000/- (Grade Pay of Rs. 6,600/- in Pay Band-3) with effect from the date of DPC held on 18th & 19th December, 2012 or the date of assumption of the charge of the post, whichever is later, *instead of date* of grant of Senior Time Scale (STS) as indicated against their names in the aforementioned Notification:-


