Box 164, St. Leonards, New South Wales, Australia-2065 by way of fees for technical services received in pursuance of the agreement dated the 27<sup>th</sup> November, 2009 entered into by the Government of India for providing services in or outside India in the project Seabird(Phase II-A) connected with security of India shall not be included in computing the total income of a previous year of the said company under the said Act.
